

Clanking Chains: Satanic Assault against a Client Nation Targets Its Children: Processing Language in the Brain

See visual: "Processing Language in the Brain" NOTE:

> When a word is <u>heard</u> it is processed by the **auditory cortex**. However, the word cannot be understood until the auditory signal is processed in a section of the brain called Wernicke's area, named after German neurologist Carl Wernicke \ver' nika\.

> If the word is to be spoken, information is transmitted to **Broca's area**, named for French surgeon Pierre-Paul Broca \braw' ka\. The signals arrive through a bundle of nerve fibers called the **arcuate fisciculus** \ar' kue-wat fa-sik' ya-lus.

In Broca's area, a program for speech is activated and supplied to the face area of the motor cortex which in turn drives the muscles of the lips, tongue, and larynx.

Wernicke's area handles semantics, the way language expresses the meaning the thinker or speaker wishes to communicate with his words.

Broca's area handles syntax, the orderly system by which words are arranged harmoniously into sentences.

Put simply, Wernicke's area deals with meaning and content while Broca's area deals with grammar and arrangement of words.

When God selects a person at physical birth, absent physical defect, that child's brain is prewired to process language. What kind of a person he becomes relies largely on his advance in that language, the thoughts that will be communicated to him through it, and the resultant attitudes, opinions, and beliefs that he will acquire from them. Bryson elaborates on the ease by which children learn and use language:

Bryson, The Mother Tongue, 26-27, 29:

By the end of the first month of life infants show a clear preference for speechlike sounds over all others. It doesn't matter what language it is. To a baby no language is easier or more difficult that any other. They are all mastered at about the same pace, however irregular and wildly inflected they may be. In short, children seem to be programmed to learn language, just as they seem to be programmed to learn to walk. Indeed, children in the first five years of life have such a remarkable facility for language that they can effortlessly learn two structurally quite different languages simultaneously without displaying the slightest signs of stress or confusion.

Where vocabulary is concerned, children are very reliant on their mothers. If she says a word, then the child generally listens and tries to repeat it. But where grammar is concerned, children go their own way. According to one study, two thirds of utterances made by mothers to their infants are either imperatives or questions, and only one third are statements, yet the utterances of children are overwhelmingly statements. Clearly they don't require the same repetitive teaching because they are already a step ahead where syntax is concerned.

All of this would seem to suggest that certain properties of language are innate. Moreover, it appears that the earth's languages may be more closely related than once thought.

It is generally conceded that the cement which holds men together in groups and nations is what we call a common culture, and the very core of such a culture is found in language, man's marvelous ability to communicate ideas.

[Note the satanic strategy against the United States: A multilingual population cannot subscribe to the same culture. After the dominant culture is deconstructed, then Lucifer will influence a crusade to teach everyone the same language.]

It is exactly at this point that the judgment of God struck; the common bond of "one language" was supernaturally destroyed, and the multiplication of tongues led to the formation of different groups and, ultimately, nations.
