- 22. The legal systems of Great Britain and subsequently the United States were developed by subscription to the principles of true freedom. Their protections were codified within establishment law. This included provisions that protected the citizen from the law's long arms without due process and maintained within a just system of jurisprudence.
- Our Founders' desire was to incorporate these institutions into the founding 23. documents of the colonies and ultimately within the several states. These laws were codified by strict attention to biblical systems in which the perfect justice of God managed mankind.
- 24. Then under the laws of liberty, citizens were allowed to go about their business freely to pursue opportunities, acquire necessities, assist others, and generally contribute to the maintenance of freedom and prosperity throughout the commonwealth.
- 25. Yet, mankind, like the angels who preceded us, have the propensity and inclination to sin, engage in wrongdoing, commit crime, and face retribution from those harmed in a court of law.
- 26. Until the downtrends accruing over the past eighteen months, our nation's system of jurisprudence had provided maximum opportunities for the free will of men to pursue their desires, objectives, and opportunities freely as long as they stayed within the boundaries of the law.
- 27. One of the primary and obligatory doctrines of our system of law is that a man may not be found guilty of a crime without due process: a trial by jury, evidence presented, witnesses questioned, and his own testimony heard.
- From this system we are able to borrow some ideas that will help us illustrate 28. from American jurisprudence teaching aids that explain the ongoing legal drama that exists on this earth.
- 29. We have established that Lucifer and his minions have sinned against God. They have been tried and found guilty. As a result, the Lake of Fire was created in eternity past as the penitentiary where the convicted demons were to be incarcerated for all eternity.
- 30. We have documented that the guilty verdict was rendered before human history was introduced in the garden of Eden in the personages of Adam and Ishah.
- 31. We have further documented that, as a result, the sentencing of Lucifer and his demons into the Lake of Fire occurred, yet this event has been halted by a divine stay of execution:

Stay: a stopping or suspension of procedure or execution by judicial or executive order.¹

- 32. This stay is a term used in American jurisprudence. When information is brought forward following a conviction, but before incarceration occurs, the defense has the legal privilege to stay the sentence and petition the court hear its appeal.
- 33. Although this procedure is part of American jurisprudence, it serves as an excellent explanation of why the guilty verdict reached by the Supreme Court of Heaven was stayed.
- 34. Lucifer petitioned the Court with an appeal, a legal tactic he used to stay the implementation of the sentence to the Lake of Fire.
- 35. For this appeal to be heard before the Divine Court of Appeals, then witnesses for the defense and witnesses for the Prosecution must be called to testify in the courtroom which God decreed would be planet earth.
- 36. The first to be called were witnesses for the Prosecution in the persons of Adam and Ishah, recorded in Genesis 2.
- 37. The first to cross-examine this couple was that cherub-rank angel, Lucifer himself— *Helel ben-Shachar*.
- 38. At this point we are now going to consult *Black's Law Dictionary* for the definitions of what is about to take place in the garden of Eden: (1) the Divine Court of Appeals is now in session, (2) Lucifer is the attorney for the defense, (3) the two witnesses for the Prosecution are Adam and Ishah, and (4) the Attorney for the Prosecution is God.
- 39. There are some idiosyncrasies in the following definitions of "appeal," nevertheless, they clearly reveal why God allowed this legal tactic to be used in this appeal. (All of the following excerpts are cited from page 124.)

Appeal. The complaint to a superior court of an injustice done or error committed by an inferior one, whose judgment or decision the court above is called upon to correct or reverse.

An "appeal" is merely a continuation of original lawsuit.

Appeal is sometimes used to denote the nature of appellate jurisdiction, as distinguished from original jurisdiction. "Appeal" has no conclusive meaning, and it is necessary in each instance to look to the particular act giving an appeal, to determine powers to be exercised by the appellate court.

An "appeal" is a step in a judicial proceeding, and in legal contemplation there can be no appeal where there has been no decision by the judicial tribunal.

"Appeal" differs from trial in that it is a review on original record after that has been made in accordance with wellrecognized principles of judicial procedure.²

- It is from these definitions that we are able to project the sequence of events 40. that occurred in time which take place between the sentencing of Lucifer and the fallen angels following their fall and the incarceration of them at the close of the dispensation of the Millennium.
- Between these two events is a period of time that involves human history. 41. Human history occurs in time. It begins with mankind's innocence and continues up to the incarceration of Lucifer and the fallen angels.
- 42. During this period of time is when the Divine Court of Appeals is in session. When the human race was created, human history began. They are the first witnesses to take the stand in the Court of Appeals, initially for the Prosecution.
- The first couple duplicated the conditions common to the angels before 43. Lucifer's fall. They were created perfect although they soon became witnesses for the defense by committing the original sin, first by Eve and second by Adam.
- 44. This fall by the original couple duplicated the fall of Lucifer. Adam and Eve and the angelic myriads were created perfect, but both used their free wills to fail.
- 45. Following the fall of mankind, both they and the fallen angels find themselves as witnesses in the divine courtroom of planet earth: (1) Adam and Eve initially testify for the Prosecution followed by (2) the fallen angels who testify for the defense.
- 46. Mankind was created to duplicate the conditions of the prehistoric angelic conflict. They were created perfect at their creation but by volitional choice they chose to violate divine policy.
- 47. This provided both evidence and precedence for Satan's appeal. The fall of man replicates Lucifer's fall and both did these things in a perfect environment.
- 48. Therefore, the arguments presented in the Divine Court of Appeals initially cover events that transpired during Old Testament history.

49. The rebuttal phase of the Prosecution is coterminous with the Christocentric dispensations: (1) the Hypostatic Union and (2) the Church. Jesus Christ and

the invisible heroes of the Church Age are witnesses for the Prosecution.

- 50. Lucifer presents his rebuttal during the Tribulation. His rebuttal arguments are characterized by violence and anti-Semitism.
- 51. Closing arguments and summary of the Prosecution includes the Second Advent and the Millennial reign of Christ. These duplicate the conditions before the fall of Satan and the fall of man in the garden of Eden.
- 52. Satan's closing argument is the Gog revolution at the end of the Millennium.

The Four Phases of Satan's Appeal:

Introduction:

- 1. There were two categories of jurisprudence associated with the fallen angels:
 - (1) **The Formal Trial.** This occurred in eternity past which resulted in the conviction of those angels who rebelled against the authority of God.

These angels are referred to as "fallen" which indicates they were found guilty by God and sentenced for eternity into the lake of fire:

Matthew 25:41 "God will say to those on His left, 'Depart from Me, accursed ones, into the eternal fire which has been prepared [perfect passive participle of ἑτοιμάζω (hetoimázō): in eternity past following the prehistoric trial] for the devil and his angels."

(2) **The Appeal.** (See excerpt above on pages 72–73, at point 39.) This judicial proceeding was granted in eternity past but did not occur until the Divine Court of Appeals was called into session in time.

The first proceeding in the Appeal occurred when the Prosecution introduced its witnesses. This occurred over the course of several passages beginning in Genesis 1:24 and concluding in 2:25.

These witnesses were created perfect. God named the first witness אַרָּ ('Atham); Αδάμ (Adám): Adam: "Man," and אַרָּ ('Ishshah); Γυνή (Gunḗ): "Woman."

Phase One: The Formal Appeal:

- The formal phase of Satan's Appeal occurred during Old 1. Testament history, beginning with the fall of man, and continued until the First Advent, i.e., the Incarnation of Jesus Christ.
- 2. Adam's fall repeated that of Lucifer's and he and those subsequent to him continued the process as did the fallen angels in the past when one-third of them joined the rebellion.
- 3. Therefore, God introduced the first Homo sapiens into human history, yet created lower than the angels. This fact is certified by and conclusive of the true humanity of Jesus Christ, Who is described thusly in:

Hebrews 2:7 "For a brief time, You [God] have made Him [Jesus] a little lower [inferior] than the angels. You [God] have crowned Him [Jesus] with glory and honor which belongs to You. (EXT)

- 4. The issue being addressed in the Appeal is angelic volition. Volition is an attribute of the soul common to both angels and men thus making them free agents with regard to personal decision making.
- 5. Volition is free. The individual, angel or man, has the autonomy to make independent decisions, good or bad, just or unjust, righteous or unrighteous, right or wrong.
- 6. Therefore, God designed mankind with free will thus making them equal with the angels in this particular way although without their physical attributes and capabilities.
- 7. The fall of mankind in the garden duplicates the fall of Lucifer in eternity past.
- 8. The sequence of events in the Appeal includes arguments presented by both the Prosecution and the defense.
- 9. The first phase of the Appeal begins with the defense which covers the Theocentric dispensations of the Gentiles and Israel.
- 10. This is followed by the Prosecution's rebuttal contained in the Christocentric dispensations of Christ and the church.
- When Adam fell, Lucifer became the ruler of this world, the 11. genius but fallen cherub-ranked angel who represents the fallen angels.

- 12. Lucifer's genius is off the charts when compared to the mentality of Homo sapiens. However, the management of the human race over the course of millennia is far more than even Lucifer's genius can consistently manage.
- 13. His efforts are focused on the creation of a perfect environment equal to that God produced with the original creation of the universe in Genesis 1:1 and which He restored back to its pristine perfection in Genesis 1:2*b*-2:4.
- 14. When Adam fell, so did the planet. Since then, it has been Lucifer's desire to restore the earth to is former perfection.
- 15. However, the planet fell with original sin and its restoration will require the intervention of the Creator, Jesus Christ, Who will accomplish that mission with the introduction of His millennial kingdom.
- 16. Nevertheless, Lucifer's objective is to restore perfection which will require him to restore the earth to its pristine perfection.

 These efforts are characterized today by the brainwashing that has taken place in the Federal Schools for the past 100 years.
- 17. Systems of government that have been shown to be either excellent or inferior have been what Lucifer has spent his time trying to implement perfection.
- 18. Economy refers to the exchange of goods and services in a way that benefits both participants privy to the process. Scripture indicates that the best system for an economy is capitalism.

- 19. All other systems of economy are far inferior and every time tried, fails miserably. Nevertheless, there always are those susceptible to Luciferian propaganda that insist their efforts will surely get it right.
- 20. There are presently those who speak about dollars numbering in the trillions which unfortunately refer to our national debt, an unfathomable number a generation ago, but is presently nearing 30-trillion dollars in the red. The next number in the math book is 1 quadrillion: \$1,000,000,000,000,000. Madness!
